

WHEREAS, The Secretary of the Department of Corrections has requested, pursuant to Sections 212 and 709(b) of *The Administrative Code of 1929*, approval to establish, under the existing Executive Deputy Secretary, the Executive Deputy Secretary for Institutional Operations; transfer the Deputy Secretary for Eastern Region, the Deputy Secretary for Western Region, and the Population Management and Sentence Computation Office from the Executive Deputy Secretary to the Executive Deputy Secretary for Institutional Operations; transfer the Security Office, the Quehanna Boot Camp, and State Correctional Institutions (SCIs) Camp Hill, Houtzdale, Muncy, and Rockview from the Deputy Secretary for Central Region to the Executive Deputy Secretary for Institutional Operations; transfer SCI Cambridge Springs from the Deputy Secretary for Western Region to the Executive Deputy Secretary for Institutional Operations; transfer SCI Benner Township from the Deputy Secretary for Central Region to the Deputy Secretary for Eastern Region; transfer SCIs Huntingdon, Pine Grove, and Smithfield from the Deputy Secretary for Central Region to the Deputy Secretary for Western Region; abolish the Deputy Secretary for Central Region; abolish SCI Pittsburgh; and

WHEREAS, The Secretary of the Department of Corrections further requests approval to establish, under the existing Executive Deputy Secretary, the Executive Deputy Secretary for Community Corrections and Reentry; under the Executive Deputy Secretary for Community Corrections and Reentry, establish the Deputy Secretary for Reentry, establish the Deputy Secretary for Field Services, and establish the Bureau of Contract Management and Evaluation, consisting of the Contract Management Division and the Evaluation Division; under the Deputy Secretary for Reentry, establish the Housing Office; establish the Institutional Parole Office under the Deputy Secretary for Reentry and transfer the renamed Western Institutional Region 1 Office, the Western Institutional Region 2 Office, the Eastern Institutional Region Office, and Central Institutional Region Office from the Pennsylvania Board of Probation and Parole (PBPP) to the Institutional Parole Office; transfer the Bureau of Central Services from the PBPP to the Deputy Secretary for Reentry; within the Bureau of Central Services, establish the Parole Services Division and consolidate the existing Interstate Parole Services Division and the Interstate Probation Services Division into the Interstate Probation and Parole Services Division; and

WHEREAS, The Secretary of the Department of Corrections further requests approval to transfer the Bureau of Probation Services from the PBPP to the Deputy Secretary for Reentry; transfer the renamed Bureau of Reentry Coordination from the PBPP to the Deputy Secretary for Reentry; transfer the renamed Western Field Region Office, the Central Field Region Office, and the Eastern Field Region Office from the PBPP to the Deputy Secretary for Field Services; transfer the Bureau of Training from the PBPP to the Executive Deputy Secretary for Community Corrections and Reentry; transfer the Bureau of Community Corrections from the Executive Deputy Secretary to the Executive Deputy Secretary for Community Corrections and Reentry; establish, within the Bureau of Community Corrections, the Security Division and rename the Programs and Administration Division to the Programs Division; and

WHEREAS, The Secretary of the Department of Corrections further requests approval to transfer the Psychology Office from the Executive Deputy Secretary to the Secretary; rename the Mental Health Advocate Office to the Advocacy Office; rename the Special Investigations and Intelligence Office to the Bureau of Special Investigations and Intelligence; establish the Criminal Investigations Division, the Administrative Investigations Division, and the Intelligence Division within the Bureau of Special Investigations and Intelligence; rename PBPP's Internal Affairs and Special Services Office to the Internal Affairs and Special Services Division and transfer it to the Bureau of Special Investigations and Intelligence; rename the County Inspection and Services Division to the County Inspection and Services Office and transfer it from the Bureau of Standards, Audits, and Accreditation to the Deputy Secretary for Administration; establish the Parole Review and Compliance Division within the Bureau of Standards, Audits, and Accreditation; and

WHEREAS, The Secretary of the Department of Corrections further requests approval to rename the Food Service Division to the Food Service Office and transfer it from the Bureau of Health Care Services to the Deputy Secretary for Administration; establish the Fiscal Accounting and Auditing Division within the Bureau of Administration; establish a reporting relationship between the PBPP and the Secretary; establish a reporting relationship between the renamed County Probation and Parole Officers' Firearm Education and Training Commission and the Secretary; establish a reporting relationship between the Sexual Offenders Assessment Board and the Secretary; abolish the Bureau of Human Resources; and abolish the Bureau of Information Technology; Therefore, be it

RESOLVED, That the Secretary of the Department of Corrections is hereby granted approval to make the above-mentioned **changes shown by (bold)**; and, be it further

RESOLVED, That the attached organizational chart reflecting the above change will be submitted to the Legislative Reference Bureau for publication in the *Pennsylvania Bulletin* and *Pennsylvania Code*.
