

- WHEREAS, The Secretary of the Commonwealth has requested, pursuant to Sections 212 and 709(b) of *The Administrative Code of 1929*, approval to establish an Executive Deputy Secretary and transfer the Deputy Secretary for Elections and Administration, the Deputy Secretary for Regulatory Programs, and the Offices of Communications and Press, Legislative Affairs, and Policy under its authority; and
- WHEREAS, The Secretary of the Commonwealth further requests approval to rename the Deputy Secretary for External Affairs and Elections to the Deputy Secretary for Elections and Administration; rename the Deputy Secretary for Administration and Regulatory Programs to the Deputy Secretary for Regulatory Programs; transfer the Bureaus of Management Information Systems, Finance and Operations, and Human Resources to the Deputy Secretary for Elections and Administration; transfer the Pennsylvania State Athletic Commission to the Deputy Secretary for Regulatory Programs; and
- WHEREAS, The Secretary of the Commonwealth further requests approval to rename the Division of Election Services to the Division of Election and Voter Services; abolish the Division of Help America Vote Act and transfer its functions to the Division of Election and Voter Services; and establish a reporting relationship from the Bureau of Human Resources to the Deputy Secretary for Elections and Administration, Department of State and the Deputy Secretary for Administration, Department of General Services; Therefore, be it
- RESOLVED, That the Secretary of the Commonwealth is hereby granted approval to make the above-mentioned changes **shown by (bold)**; and, be it further
- RESOLVED, That the attached organizational chart reflecting the above changes will be submitted to the Legislative Reference Bureau for publication in the *Pennsylvania Bulletin* and *Pennsylvania Code*.

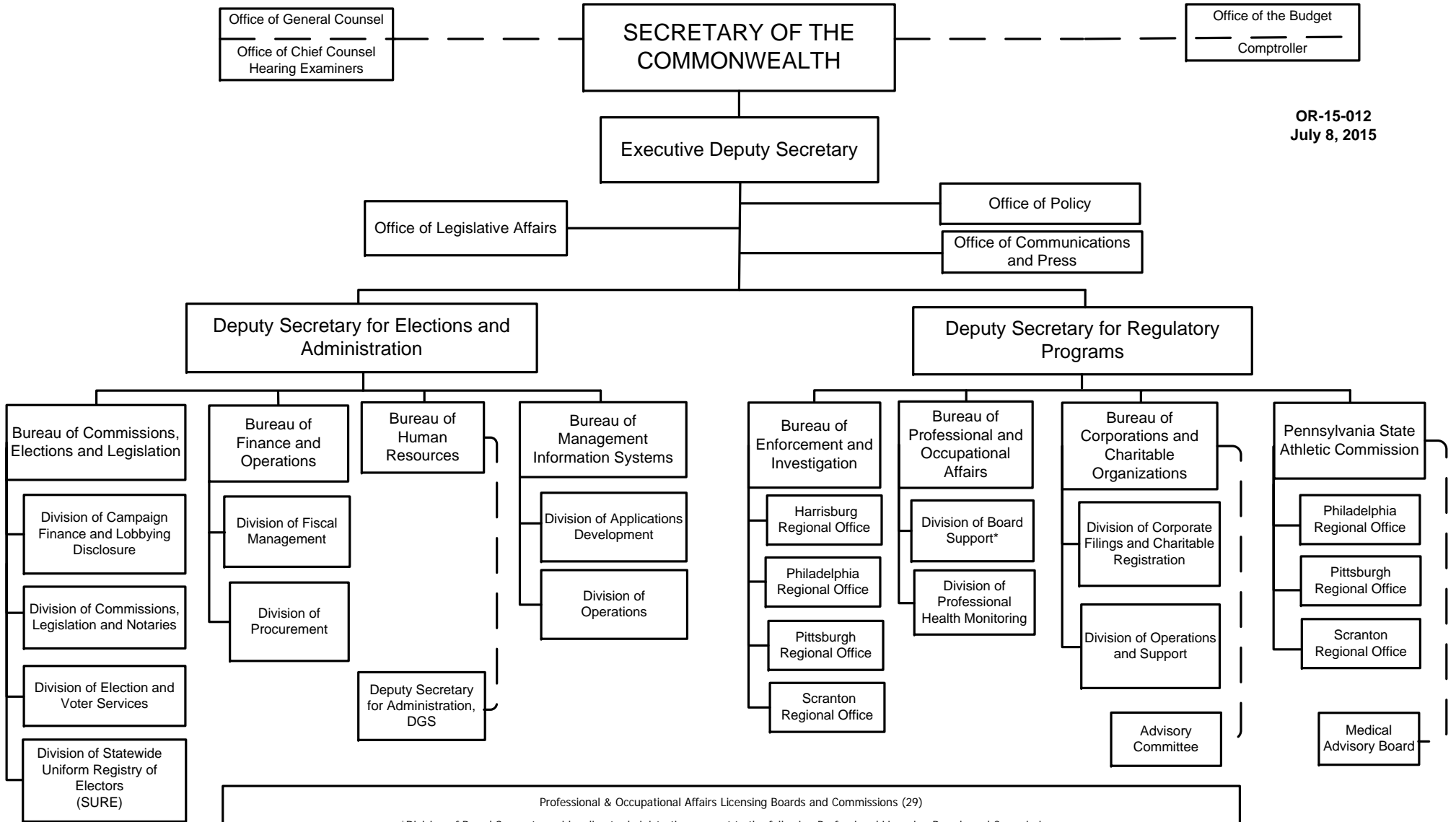
