- **Action:** review the topics and decide on appropriate disposition during the next joint task force meeting.

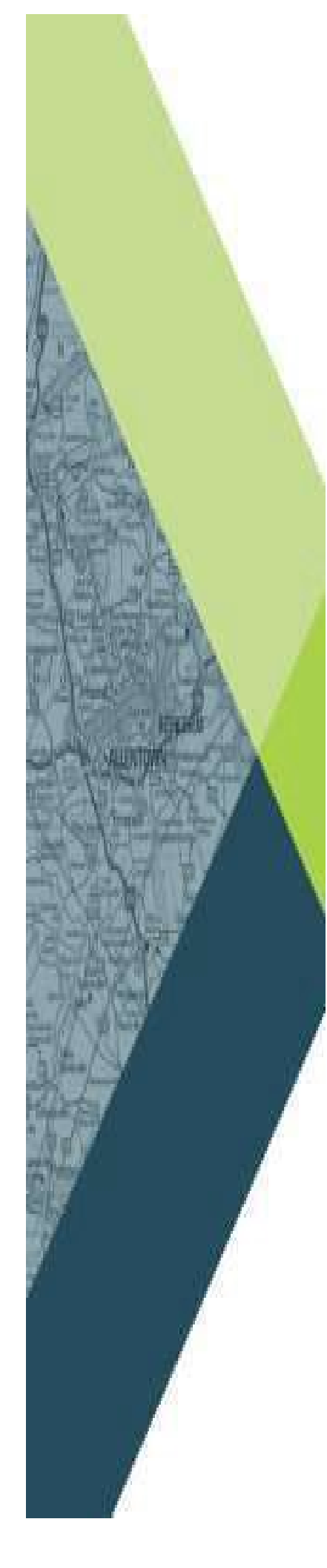
