NENA Standards

The 60 day public comment period for the **NENA Standard NG9-1-1 GIS Data Model** was closed on February 28, 2017.

165 comments were received during this time period. These comments will be referred to the Working Group for this standard for review and resolution. Comments concerning punctuation, grammar change, grammar consistency, definition clarification, etc. will be resolved in a short amount of time. Additional wordsmithing of the document will take additional time.

There are some comments/recommendations which will take the working group more time to resolve. As an example: there is a recommendation to remove the Landmark Name Part Table Section 4.6 and 4.61 from the standard as being too complicated and having "no clear benefit to the NG9-1-1 system." Recommendations concerning inclusion of the US National Grid will also take more time to both discuss and resolve.

NENA Standards

It is expected that the NENA Working Group for the NG9-1-1 GIS Data Model will begin reviewing the public comments this month (March).

On the heels of NENA's members meeting with Congressional leaders at 9-1-1 Goes to Washington, as well as The Hill's publication of an op-ed by NENA's CEO calling for Federal NG9-1-1 support, Senators Nelson and Klobuchar have released draft legislation that would make the transition to NG9-1-1 a national priority.

As the only ANSI-accredited standards development organization working on NG9-1-1, and the developer of the consensus standard for NG9-1-1, $\underline{i3}$, NENA is pleased to see a strong emphasis on standards-based deployment of this safety-critical technology.

Further, as a founding member of the NG9-1-1 Now Coalition, NENA is exceptionally proud that its work has led to the release of this draft. The text of this bill closely tracks NENA's recommendations for an NG9-1-1 legal framework, first filed with the FCC almost five years ago, and we're grateful to Senators Nelson and Klobuchar for listening to the voice of our members.


