Task Force Updates

 Kevin Eaton, Sean Crager, and Laura Simonetti each presented slides providing updates for each of the task forces they represent.

- During the Governance Task Force, the Strategic Goals and Objectives were discussed in detail.
 - The Board was requested to review the draft strategic plan and submit any feedback or comments by August 24, 2017, to gis@franklincountypa.gov
- During the Data Program Task Force, Crystal Fox discussed examples of past Data Sharing Agreements.
 - Crystal Fox encouraged all Board Members to have their organizations contact her and encouraged participation in the creation of a data sharing agreement.

New Business

- Jeff Boyle provided a brief update on behalf of PEMA.
 - o Working with the Department of General Services (DGS) to finish statement of work.
 - o Received four (4) grant applications in the 911 office relating to GIS.
- Barry Hutchins provided a brief update on behalf of NENA.
 - o NENA is half-way through reviewing the 208 public comments.
 - Anticipate completion of this review by Thanksgiving before conducting another round of public comments.
 - o Mr. Hutchins will distribute a revised copy shortly after it becomes available.

- The Board was informed that there is a piece of legislation currently circulating for review that might interest the Board;
 - o Legislation is US Senate Bill 1253 (S1253)

- Several comments/questions were made regarding US Senate Bill 1253:
 - Barry Hutchins recommended the Board review the bill and reviewing the positions several GIS organizations have taken regarding this bill.
- Eric Jespersen brought up the previously discussed topic at the last GeoBoard meeting regarding PA House Bill 1106 (HB1106), and inquired if these types legislations are appropriate to be discussed by the GeoBoard.
 - This topic was discussed in detail by several members and attendees.
 - The Governance Task Force is going to discuss current legislation and bring it back for discussion at the next GeoBoard meeting.
- John MacMillan requested volunteers to assist in composing outreach messages.
- John MacMillan reviewed the new agenda management for future GeoBoard meetings.
 - o Barry Hutchins commented about incorporating a mechanism that would allow a non-Board member or organization to add an agenda/discussion item.
- Future meeting topics were discussed:
 - o Kevin Eaton nominated the US Census Bureau to speak at the next GeoBoard meeting.
 - Maurie Kelley requested that a Chesapeake Bay program or a non-profit speak at a future meeting.
 - Maurie Kelley requested a short presentation, or communication, from Nikki Ernst on the upcoming GIS Day. Will be distributed to members.
 - Scott Zubek had an agenda request, but the information he was seeking was provided by an audience member, Carrie Tropasso.
- Sean Crager discussed future meeting cadence for individual Task Force, Joint Task Force and GeoBoard meetings. Once established; scheduled meetings will be added to calendars.
