- Sean Crager inquired about what mechanisms the US Census Bureau had in place for obtaining data sharing agreements with both county and state governments.
- John MacMillan advised the Board that one initiative is data sharing and another is a base map layer and asked how this information could further the Board's goals.
- Barry Hutchins and Matthew Warner both indicated that the way PA codes and regulations are written that it adds another layer of complexity to the issues being discussed.

- During the Data Program Task Force, the Data Sharing Agreement and Base Map were discussed in detail.
- During the Governance Task Force, the Strategic Plan and House Bill 1106 were discussed in detail.
 - The Strategic Plan was out for comment and review and received ten (10) responses back.
 - The Legislative Subcommittee reviewed HB1106 and is working on a draft recommendation to be presented to the GeoBoard at the next Board meeting.
- During the Service Delivery Task Force, it was shared that PASDA was identified as the state wide data portal.

- Barry Hutchins provided a brief update on behalf of NENA.
 - NENA has reviewed 138 out of 208 public comments.
 - As soon as second draft goes out for comment, a copy will be provided to the GeoBoard.

- John MacMillan indicated to everyone that volunteered for outreach messages that a writing assignment would be forthcoming.
