

WHEREAS, The Secretary of the Department of Aging has requested, pursuant to Sections 212 and 709(b) of *The Administrative Code of 1929*, approval to transfer the Ombudsman Office from the Deputy Secretary of Aging to the Secretary; transfer the Bureau of Pharmaceutical Assistance (PACE) from the Deputy Secretary of Aging to the Secretary; establish the Finance Division in the Bureau of Pharmaceutical Assistance (PACE); abolish the Operations Division in the Bureau of Pharmaceutical Assistance (PACE); consolidate the Budget Division and the Procurement Division in the Bureau of Finance and rename them the Budget and Procurement Division; rename the Contracting Division in the Bureau of Finance to the Vendor Operations Division; rename the Protective Services Office to the Bureau of Protective Services; and establish the Protective Services Division and the Criminal History Background Check Division; Therefore, be it
