

- WHEREAS, The Secretary of the Department of Corrections has requested, pursuant to Sections 212 and 709(b) of *The Administrative Code of 1929*, approval, to transfer the Victim Services Office dotted line relationship from the Executive Deputy Secretary to the Secretary; transfer the Bureau of Standards, Audits, Assessment and Compliance from the Executive Deputy Secretary to the Secretary; transfer the Executive Deputy Secretary for Institutional Operations from the Executive Deputy Secretary to the Secretary; transfer the Executive Deputy Secretary for Community Corrections and Reentry from the Executive Deputy Secretary to the Secretary; transfer the Bureau of Correction Education from the Executive Deputy Secretary to the Secretary; rename the Intelligence Division in the Bureau of Investigations and Intelligence to the Analytics Division; rename the Internal Affairs and Special Services Division in the Bureau of Investigations and Intelligence to the Field Intelligence Division; abolish the Executive Deputy Secretary; and
- WHEREAS, The Secretary of the Department of Corrections further requests approval to transfer and rename the Population Management and Sentence Computation Office from the Executive Deputy Secretary to the Executive Deputy Secretary for Institutional Operations as the Bureau of Population Management and Sentence Computation; establish the Population Management Division and the Sentence Computation Division in the Bureau of Population Management and Sentence Computation; transfer the County Inspection and Services Office from the Deputy Secretary for Administration to the Executive Deputy Secretary for Institutional Operations; and
- WHEREAS, The Secretary of the Department of Corrections further requests approval to rename the Bureau of Reentry Coordination to the Reentry Coordination Office in the Office of Reentry; abolish the Specialized Services and Community Outreach Division and the Transition Services and Staff Liaison Division in the Bureau of Reentry Coordination; establish the Probation and Court Services Division in the Bureau of Central Services; rename the Interstate Probation and Parole Services Division in the Bureau of Central Services to the Interstate Division; abolish the Bureau of Probation Services and the Grants, Standards, and Court Services Division; and
- WHEREAS, The Secretary of the Department of Corrections further requests approval to transfer the Bureau of Treatment Services from the Executive Deputy Secretary to the Deputy Secretary for Administration; establish the Office Services Division in the Bureau of Administration; establish the Contract Maintenance and Vehicle Management Division in the Bureau of Administration; and abolish the Administrative Services Division, the Fiscal Accounting and Auditing Division, and the Contract Management and Evaluation Division in the Bureau of Administration; Therefore, be it
