

## EXECUTIVE BOARD RESOLUTION

**RESOLUTION NO. OR-24-007**  
**April 18, 2024**

WHEREAS, The Secretary of the Department of Education has requested, pursuant to Sections 212 and 709(b) of *The Administrative Code of 1929*, approval, in the Office of Administration, to transfer the Division of Food and Nutrition from the Bureau of Budget and Fiscal Management to the Office of Administration and rename it to the Bureau of Food and Nutrition; establish the Division of Child and Adult Care Food Program, the Division of Summer Food Service Program, the Division of School Nutrition Programs, the Division of Child Nutrition Program Compliance, the Division of Child Nutrition Program Fiscal Management, the Division of Child Nutrition Program Procurement and Resource Management, and the Division of Child Nutrition Program Administrative and Technical Support in the Bureau of Food and Nutrition; rename the Bureau of Budget and Fiscal Management to the Bureau of Financial Operations; establish the Division of Fiscal Services in the Bureau of Financial Operations; and rename the Division of Budget to the Division of Central Budget and the Division of School Facilities to the Division of School Finance Review in the Bureau of Financial Operations; and

WHEREAS, The Secretary of the Department of Education has further requested approval, in the Office of Postsecondary/Higher Education, Bureau of Postsecondary and Adult Education, to rename the Division of Law Enforcement Education and Trade Schools to the Division of Postsecondary Proprietary Training, establish the Division of Law Enforcement Education, and abolish the Philadelphia Office in the Division of Veterans' and Military Education; and

WHEREAS, The Secretary of the Department of Education has further requested approval to rename the General Government Human Resource Delivery Center to the Education HR Office; Therefore, be it

RESOLVED, That the Secretary of the Department of Education is hereby granted approval to make the above-mentioned **changes shown by (bold) and an asterisk\***; and, be it further

RESOLVED, That the attached organizational chart reflecting the above changes will be submitted to the Legislative Reference Bureau for publication in the *Pennsylvania Bulletin* and *Pennsylvania Code*.

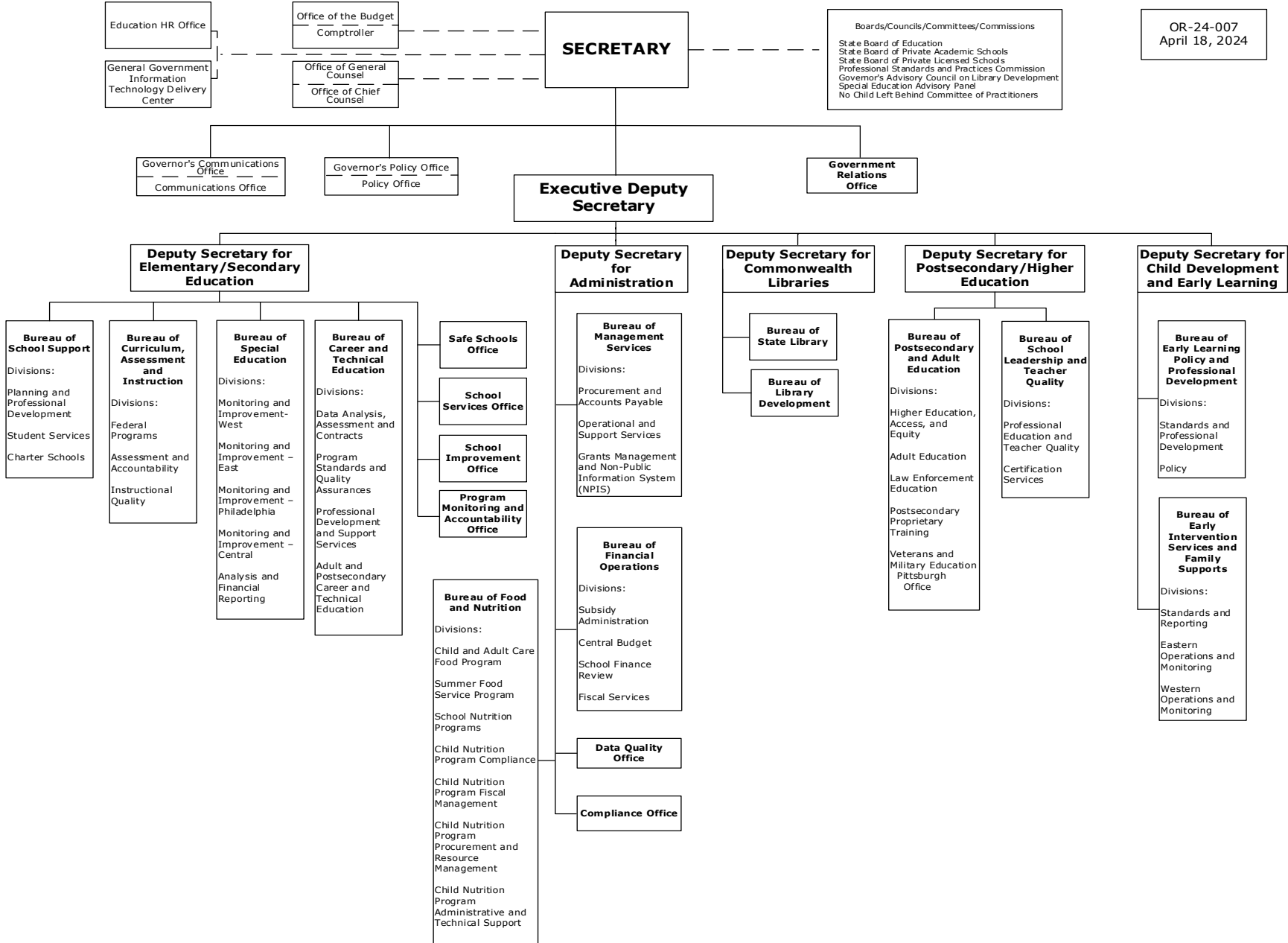
