

## EXECUTIVE BOARD RESOLUTION

**RESOLUTION NO. OR-23-015**  
**August 18, 2023**

WHEREAS, The Secretary of the Department of Environmental Protection has requested, pursuant to Sections 212 and 709(b) of *The Administrative Code of 1929*, approval to rename the Executive Deputy Secretary for Administration and Management to the Deputy Secretary for Administration; transfer the Program Integration Office from the Office of Field Operations to the Office of the Secretary and rename it to the Center for Environmental Excellence; establish the Interstate Water Resources Management Division in the Bureau of Safe Drinking Water; rename the Cleanup Standards Division to the Land Recycling Program Division in the Bureau of Environmental Cleanup and Brownfields; rename the Permitting and Compliance Division to the Permitting and Licensing Division and the Environmental Analysis and Support Division to the Environmental Analysis and Compliance Division in the Bureau of Mining Programs; and abolish the Air Information Division in the Bureau of Air Quality; Therefore, be it
