WHEREAS, The Executive Director of the Pennsylvania Game Commission has requested, pursuant to Sections 212 and 709(b) of *The Administrative Code of 1929*, approval to rename the Bureau of Marketing and Communications to the Bureau of Marketing and Strategic Communications; establish the Shooting Sports Division in the Bureau of Marketing and Strategic Communications; transfer the Training School from the Deputy Executive Director for Regional Operations and Training to the Bureau of Wildlife Protection and rename it to the Training Division - Ross Leffler School of Conservation; and rename the Deputy Executive Director for Regional Operations and Training to Deputy Executive Director for Regional Operations; and

WHEREAS, The Executive Director of the Pennsylvania Game Commission further requests approval to rename the Media Services Division to the Social Science and Conservation Education Division in the Bureau of Information and Education; rename the Research and Education Division to the Hunter-Trapper Education and Outreach Division in the Bureau of Information and Education; establish the Wildlife Health Division in the Bureau of Wildlife Management; rename the Wildlife Diversity Division to the Wildlife Recovery Division in the Bureau of Wildlife Management; and rename the Wildlife Services Division to the Wildlife Operations Division in the Bureau of Wildlife Management; Therefore, be it
