1. Purpose

This <u>Information Technology Policy (ITP)</u> establishes the enterprise-wide policy and standards for Windows and Linux-based servers.

2. Scope

This ITP applies to all offices, departments, boards, commissions, and councils under the Governor's jurisdiction and any other entity connecting to the Commonwealth Network (hereinafter referred to as "agencies").

Third-party vendors, licensors, contractors, or suppliers shall meet the policy requirements of this ITP that are applicable to the products and services provided to the Commonwealth as outlined in the Responsibilities Section.

3. Policy

All projects implementing Windows and Linux server operating systems shall adhere to product standards as defined in the <u>STD-PLT005B</u>, <u>Server Operating Systems</u> <u>Standards</u>. If a product is not listed within the Current Standards table in <u>STD-PLT005B</u>, agencies shall obtain an approved <u>IT Policy Waiver</u> before procuring or deploying a non-standard product. Emerging or research technologies also require an approved IT Policy Waiver.

All products shall be deployed and kept up to date with patch levels in accordance with ITP-SEC041, Commonwealth IT Resource Patching Policy.

3.1 Windows Server Platform

Agencies investing in Windows server infrastructure shall continue to monitor the Microsoft Product Roadmap and plan hardware and software deployments

accordingly. Minor releases shall be deployed on a tactical, as-needed basis; major releases shall be deployed only after extensive application and integration testing has been performed.

Agencies shall develop plans to migrate from products that are listed in "Contain" status. Microsoft typically ends mainstream support five (5) years after their Release to Manufacturer (RTM) date, which is followed by five (5) years of extended support, end-of-life, including end of security patch releases, occurs ten (10) years after RTM. A migration plan shall be completed no later than two (2) years prior to end-of-life to allow sufficient time for testing and the actual migration.

3.2 Linux Server Platform

Agencies shall implement only standard kernel releases and shall not modify the Linux kernel. Modifying and recompiling the Linux kernel could nullify the vendor support contract and may affect application portability.

Note: Enterprise versions of Red Hat and SUSE have their products certified as Linux Standard Base (LSB). LSB helps increase the compatibility among Linux systems and enables software applications to run on any conforming system. It also helps coordinate efforts to allow independent software vendors to port and write products for such systems.

3.3 Naming Standards

Agencies shall adhere to <u>OPD-PLT005A</u>, <u>Server Naming Standards</u> (Commonwealth access only), which details the requirements for the configuration of servers and their naming conventions.

Any servers deployed on and after the effective date detailed in *OPD-PLT005A* not in compliance with this policy shall obtain an IT Policy Waiver approval, against this policy, prior to deployment of said servers into an operational environment.

4. Responsibilities

4.1 Agencies shall:

Adhere to the product and naming standards detailed in *OPD-PLT005A* and *STD-PLT005B*.

4.2 Office of Administration, Office for Information Technology shall:

Comply with the requirements as outlined in this ITP.

4.3 Third-party vendors, licensors, contractors, or suppliers shall:

Adhere to the standards for the server operating systems as detailed in this ITP for systems used by the Commonwealth.
